1. A non refundable registration fee of \$50.00 and a non refundable book fee of \$200.00 are due upon registration. Monthly tuition is due by the first day of each month, beginning September 2, 2008 and the last payment being due as agreed above, for a total of \$ 1900.00 in tuition for the above named child. Refunds will not be given for children withdrawn after the start of each month. Any fee and/or tuition that is not paid at the end of two weeks after such fee and/or tuition were originally owed; the child will automatically be dismissed unless the parents make definite arrangements for payments.
2. Please consult the current school calendar for start and close dates, as well as “no school” and “break” dates. There may be additional “no school days”, every attempt will be made to notify you of such days at least one week in advance, except in emergencies.
3. In case of illness or accident when a parent cannot be contacted, and in the judgment of the worker or staff, the illness or accident requires a physician, the parent hereby authorizes that

4. In **ALL** emergencies, parent hereby grants permission to take such reasonable measures as are, in the judgment of the worker or staff, necessary to the welfare and safety of the child.
5. Parent agrees that the following symptoms are cause for keeping their child home; cold, coughing, flushed skin, earache, red eyes, chills,

6. headache, sneezing, rashes or other skin eruptions, sore throat, fever, and vomiting. In the event of a contagious illness, the parent will notify the school and remove the child and not allow him/her to return until all danger of contagion is past. LCA reserves the right to request a note from your doctor stating that the child no longer poses a risk to others. Parent has filed with the Academy a current health report, immunization records, custody statement, and birth certificate for their child. Parent has also given full details and phone numbers where they can be reached at all times that their child is in our facility or care, as well as an emergency contact number.
7. Parents are requested to participate in at least two (2) conferences per year with the child's teacher, dates of conferences and other events will be announced.
8. LCA reserves the right, and has sole discretion, to dismiss any child if after entering school he/she is unable to participate in group experiences.
9. Liability for the acts of a child while he/she is under the care of LCA is the parent's responsibility.
10. LCA is not responsible for accidents or illnesses occurring to the child while in its care; unless it can be proved that the accident was the direct result of negligence. Parent submits to the jurisdiction of the Mesa County Court and the laws of the State of Colorado.
11. Parent will give two (2) weeks written notice when withdrawing the child from the care of LCA.
